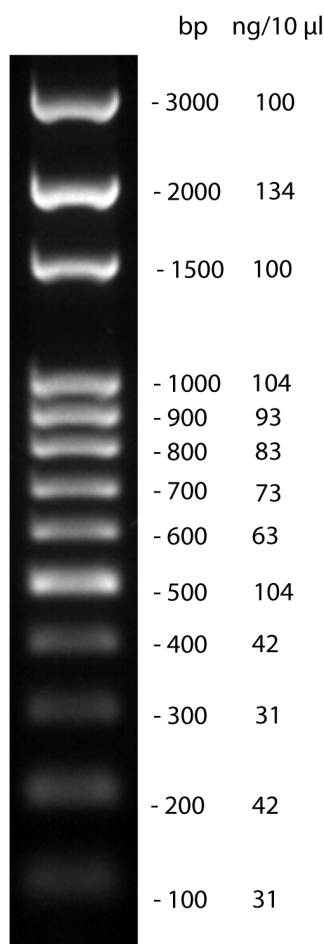

Description:

The 100 bp DNA Ladder is a ready-to-use molecular weight marker suitable for DNA fragment size determination on gel electrophoresis. The 100 bp DNA Ladder is formulated to run accurately and to provide crisp band patterns. It contains bromophenol blue dye which serves as visual aid to monitor the progress of migration during agarose gel electrophoresis. The 100 bp DNA Ladder contains 13 discrete DNA fragments ranging from 100 bp to 3,000 bp.

Recommendations:

For best results, load 5–10 µl of the 100 bp DNA Ladder per well.

The choice of voltage, time, buffer and agarose % in the gel is adjustable. Example agarose gel electrophoresis run conditions:

- For 1% agarose in 1xTBE, use 150V for a minimum of 45 minutes.
- For 2% Agarose gel in 1xTBE, use 130-150V for a minimum of 2 hours.

Storage solution:

10 mM EDTA, 10% glycerol, 0.015% bromophenol blue and 0.17% SDS.

Shipping and Storage conditions:

Routine storage: -18°C to -28°C

Shipping and temporary storage for up to 1 month at room temperature has no detrimental effects on the quality of the product.
