### Description:

HOT FIREPol® EvaGreen® HRM Mix is a 5x-concentrated ready-to-use solution for High Resolution Melt (HRM) Analysis, incorporating EvaGreen® dye. It comprises all the components necessary to perform qPCR and HRM Analysis: HOT FIREPol® DNA Polymerase, ultrapure dNTPs, MgCl<sub>2</sub>, EvaGreen® dye and ROX dye according to system requirements. The user simply needs to add water, template and primers.

HOT FIREPol® DNA Polymerase is activated by a 12 min incubation step at 95°C. This prevents extension of non-specifically annealed primers and primer-dimers formed at low temperatures during qPCR setup.

<sup>2</sup> To activate the polymerase, include an incubation step **at 95°C for 12 minutes** at the beginning of the qPCR cycle.

<sup>3</sup> The annealing temperature (T<sub>a</sub>) depends on the melting temperature (T<sub>m</sub>) of the primers. A T<sub>a</sub> that is about 2 to 5°C lower than the T<sub>m</sub> of the primers is generally suitable. Performing temperature gradient is recommended.

<sup>4</sup> For templates longer than 150 bp, the annealing and extension time may be increased to 30 sec.

For HRM step please use settings recommended by the instrument manufacturer.

EvaGreen® is compatible with all common real-time PCR cyclers – simply select the standard settings for SYBR® Green or FAM!
